

propel Half Label Comparison – Hard Copy Top Half



- *NEW* Fill Type indicates the Fill Type (e.g., NEW, REFILL, REAUTH, HOLD, RTF = Refusal to Fill) for the prescription. For Owe Balances, an *OWE* indicator appears instead.
- *NEW* Status indicates the prescription or label status (e.g., *RB* = Rebill, *AMD* = Amend, *RP* = Reprint, *CAN* = Cancelled, *TRN* = Transferred). If multiple actions were performed on a prescription, the most recent status is printed.
 - *NEW* LAN indicates the primary language set in the Patient Folder Preferences tab.
- Auto Refill Enrollment indicates the Auto Refill enrollment status for the patient instead of the prescription. Statuses include A = Auto Refill Enrolled and AD = Auto Refill Declined.
- 5 **Drug Name** Trade and Trade & Innovator options for the drug name have been removed to adhere to labelling standards. The drug name continues to print according to the settings in the Drug Folder, Group Folder, and Rx Detail. Mixture prescriptions will always display the generic and trade name. The generic name is replaced with TallMan if it exists in the Drug Folder (not applicable for mixtures).

In Nova Scotia, for insulin prescriptions, the trade name always prints on the first line and the generic name on the second.

6 **Quantity** – for Owe Balances, this is the quantity being dispensed for the Owe Balance. For methadone prescriptions, this is the number of millilitres per dose up to 1 decimal place.





NEW Item # - this is the item number for the pack size used to fill the prescription. If multiple packs are used, this does not appear.

Watermarks and Refrigeration – indicates if a drug is High Alert (*NEW*), Opioid, or Trial (Alberta). If a drug is refrigerated, a snowflake icon (*NEW*) prints beside the watermarks, if any.

NEW Formulary Designation – for banner stores, this indicates the primary or secondary designation of the drug on the banner formulary.

Pack Size – if more than 1 pack size is used to fill a prescription, up to 2 pack sizes can now print here. When this occurs, a Multi header prints followed by each pack size and its On Hand value. For mixture prescriptions, the PK# and On Hand do not print. For Owe Balances, the On Hand does not print.

LOT and EXP/BUD – this is the lot number and expiry date entered in Packaging or if Packaging is off, the Rx Detail Extended tab. If multiple packs are used to fill a prescription, the lot number and expiry date of the earliest expiring pack size prints. For mixture prescriptions, BUD prints instead of EXP. For Owe Balances, the lot number and expiry date must always be entered manually.

Attachments – the Attachments indicator has been moved into the prescription section of the Hard Copy.

Qty Left/Rep – Qty Left prints instead of Rep if the **Use Qty Left for Repeats** preference is ON. Qty Left always prints if a partial fill is left. In Manitoba, Qty Left always prints.

NEW Qty Packaged and Qty Owed – indicates the quantity packaged for the current fill and the quantity owed, if any. If nothing is owed, Qty Packaged is the same as Qty. For mixture prescriptions, the Qty Owed will always be blank.

NEW Time – indicates when the prescription was packaged (if Packaging is ON), filled (if Packaging is OFF), or placed on Hold. For Cancelled prescriptions, this field does not appear. Time is updated on Rebills and Amends.

NEW Interval and Rx Expiry – indicates the interval and prescription expiry date as entered in the Rx Detail Extended tab.

Prev DIN and ***NEW* Prev SIG** – the DIN and SIG of the previous prescription in the same chain prints below the Interval and Rx Expiry, if applicable. The Prev DIN header replaces the REPL header that used to print.



Special Warnings – special warnings for the prescription print on 2 lines. The first line can print *ADD'L INSTRUCTIONS*, *DELIVERY*, *Prev. On Hold*, *Pain Management* (methadone), or *Refusal to Fill – Not Dispensed*. The second line can print Dbl Co (Double Count), Snap Caps, C-PACK, packager device name, or 🗣 (PrescribeIT^M).

When Packaging is ON, the initials of the user who confirmed the Double Count and/or Snap Caps print beside the warning (*NEW*). For Owe Balances and when Packaging is OFF, the initials do not print for Double Count and/or Snap Caps.



NEW SSC and INTV – if Special Service Codes and/or intervention codes were used to bill the prescription, they are printed to the left of the gross profit. The bill codes will be listed along with the Special Service Codes and/or intervention codes that were used.

Verification Boxes – the verification boxes have been aligned horizontally and renamed to correspond with Propel Rx Workflow: DE = Data Entry, PKG = Packaging, TECH = Technical Validation, and CLIN = Clinical Review.

In British Columbia, 6 boxes are available which are named as follows: Entry Check, Allergy, P.Net, DT Issues, Final Check, and Consult.

For Hold prescriptions, the PKG box does not print. For Owe Balances, only the PKG and TECH boxes print.

Dialogue – if Dialogue was completed before the label was printed, the Dialogue checkboxes (e.g., Accepted, Patient) would be preselected on the label.

NEW Admin Times – indicates the Admin Times for the prescription.

NEW Stop Date – indicates the Stop Date for the prescription as entered in the Administration Details window.
